#### 6. STATEMENTS AND COMMUNICATIONS BY THE SPEAKER

- a) The Speaker informed the meeting that:
  - 1. On 17 October 2022 a motion, from the majority of Councillors, was received, requesting an Urgent Special Council Meeting within 72hours for the removal of the Executive Office Bearers.
  - 2. He, as Speaker, responded to this correspondence and informed the relative Councillors that he takes cognisance but he is obligated to perform his duties within the Rules of Order and cannot grant permission for their request.
  - 3. The Rules of Order is clear, if a motion of this nature is to be considered, a period of 7 days must pass and on the eighth day be tabled before Council or handled by the discretion of the Speaker of Council.
