RB7.1.3/09-12-2022 - AMENDMENTS TO INCOME, OPERATIONAL AND CAPITAL EXPENDITURE PROJECTIONS – ADJUSTMENTS BUDDGET 2022/2023 - DECEMBER 2022), a vote was then taken to decide on the Adjustment Budget.
- Cllr Hayes protested and pointed out that in this instance (i.e., 22 December) no vote was asked for or taken to reach a decision on the Adjustments Budget of 22 December 2022. The Adjustments Budget therefore cannot be considered approved because no voting took place.

- Cllr Hayes responded that he was waiting for the Speaker to call a vote on the Adjustments Budget as was the case on 9 December 2022.
