RE: APPLICATION FOR EXTENSION OF TIME PROVISIONS IN TERMS OF REGULATION 23(1) OF THE MUNICIPAL BUDGET AND REPORTING REGULATIONS

I refer to the communication received by my office on 27 February and 7 March 2023 from your municipality in which a second extension is requested for the tabling of the adjustment budget required in Section 28(2)(b)(d)(f) of the Municipal Finance Management Act (Act 56 of 2003)(MFMA).

The application for an extension of time limits was assessed in terms of Regulation 63 of the Municipal Budget and Reporting Regulations (MBRR). In addition, Provincial Treasury has assessed your second application and circumstances surrounding it. Your application indicates that the reasons for this second requested extension are:

 The previous Schedule G (dated 27 February 2023) request did not make adequate provision for internal processes and the time required by the Rules of Order to call meetings.

After taking into consideration all requirements outlined in regulation 63 and 64 of the MBRR your Schedule G application for a further extension of one working day, to table your adjustment budget by 13 March 2023 is approved.

The comments on the financial difficulties facing the Municipality, as noted in my previous response letter dated 28 February 2023, still stand.
