REQUEST FOR PROPOSAL (RFP) FOR THE DEVELOPMENT OF RENEWABLE ENERGY SOLUTIONS IN THE CEDERBERG MUNICIPAL AREA

Cederberg Municipality hereby request proposals from reputable and competent Engineering, Procurement and Construction (EPC) Contractors to design, procure, construct, operate and maintain renewable energy solutions with or without storage capabilities in Clanwilliam and Lamberts Bay for a period of twenty (20) years under a turn-key agreement.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data (Clause C.2.1) are eligible to submit tenders.

All bids received shall be evaluated in terms of the Cederberg Municipality's Supply Chain Management Policy and Cederberg Municipality Preferential Procurement Policy of 2022/23. Both the 80/20 and 90/10 preference points systems will apply, and the lowest acceptable tender will be used to determine the applicable preference point system. Tenders will be evaluated in terms of price (90 or 80) and preference (BBBEE status 50% (5 or 10) and Locality 50% (5 or 10)).

The successful tenderer must also be registered on the Centralized Supplier Database (CSD). Tenderers can register on www.csd.gov.za.
