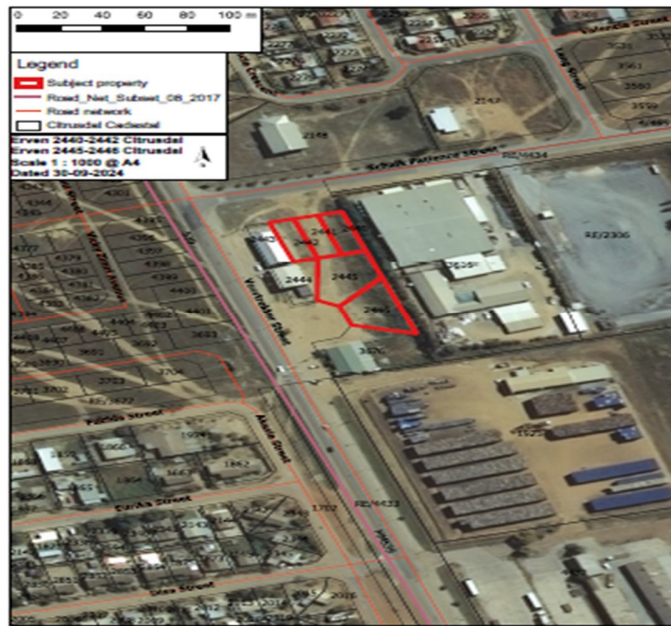
Tenders are hereby invited for the abovementioned "ALIENATION OF ERF 2441, CITRUSDAL."
